Executive Order No. 2015-001-A

FURTHER AMENDING EXECUTIVE ORDER NO. 2014-019, AS AMENDED BY EXECUTIVE ORDER NO. 2015-001, BY FORMALLY ADOPTING A NAME FOR THE LERC PROGRAM AND ESTABLISHING CITY AND BARANGAY TECHNICAL WORKING GROUPS (TWGs) TO EXPEDITE ITS IMPLEMENTATION:

WHEREAS, there is a need to formally adopt a name for the LERC program;

WHEREAS, there is a need to create a Technical Working Group (TWG), both at the city and barangay levels, that shall take the lead in implementing the program and regularly monitor its systematic implementation, and whose inputs are indispensable to the proper conduct of activities of the LERC Task Force;

NOW THEREFORE, I, JOHN G. BONGAT, City Mayor of Naga, by virtue of the powers vested in me by law do hereby order the following:

Section 1 and 4, as amended, shall now read thus:

“Section 1. Definition. As used in this Executive Order, the term *“least economically resilient communities”* shall mean residential area clusters within Naga City that suffer from inadequacy or are characterized by the following living conditions:

- a. With inadequate or no access to basic services particularly power, potable water and/or decent sanitation facilities;
- b. Where majority of the residents do not have regular sources of income or with earnings not sufficient to support the basic needs of families like food, clothing, education, health and nutrition; and
- c. Whose residents are considered as informal settlers.

This program shall be known as the “Ginhawang Nagueño Program of the City Government of Naga.”

“Section 4. The LERC Task Force. In order to address these concerns, a Task Force is hereby created composed of the following:
