Executive Order No. 2015-010

**ESTABLISHING THE INTEGRATED COMMUNITY FOOD PRODUCTION
COMMITTEE AND TECHNICAL WORKING GROUP:**

WHEREAS, the City of Naga identified the Integrated Community Food Production (ICFP) as one of its priority projects and was able to obtain funding for its implementation under the 2015 Bottom-Up Budgeting (BUB) Process;

WHEREAS, the ICFP aims to alleviate and/or eliminate hunger, and reduce the incidence of malnutrition of children in 675 target families residing in the city's least economically resilient communities;

WHEREAS, there is a need to create a subcommittee within the Local Poverty Reduction Action Team that will oversee the implementation of the program and a technical working group that will provide technical support and guidance;

NOW THEREFORE, I, JOHN G. BONGAT, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. CREATION. A subcommittee to be known as Integrated Community Food Production Subcommittee (ICFPS) is hereby created under the Local Poverty Reduction Action Team to be composed of the following:

Co-Chairperson: Dr. Augusto R. Nieves, Co-Chairperson of LPRAT

Members: Hon. Cecilia Veluz-De Asis, Chairperson
SP Committee on Agriculture
Ms. Edna Bongalonta, OIC - City Agriculture Officer
Ms. Teresita Del Castillo, City Population
& Nutrition Officer
Ms. Annabel Vargas, OIC- City Social Welfare
Development Officer
Three (3) Civil Society Organization LPRAT Members
to be chosen by the ICFPs during the initial meeting

SECTION 2. FUNCTION. The ICFP shall perform the following functions:

1. Formulate plans and prepare budgetary components of the ICFP and implement the same;

2. Identify family beneficiaries residing within the least economically resilient communities with malnourished school-aged children and/or with family members who are different-abled persons (PWDs)
3. Monitor program implementation and undertake possible courses of action for its sustainability and attainment of goals;

SECTION 3. TECHNICAL WORKING GROUP. In order to provide technical support and ensure the day-to-day monitoring of program components, a Technical Working Group is hereby created composed of the following city government personnel and private partners:


SECTION 4. FUNDING AND FUND MANAGEMENT. The amount of One Million Eight Hundred Twenty Thousand (Php 1,820,000.00) pesos shall be downloaded from the National Anti-Poverty Commission (NAPC) through BUB and shall serve as funding of the subcommittee and its TWG. Fund disbursements and financial reporting for purchase of supplies, materials and goods as well as for payments of honorarium shall be the responsibility of the City Agriculture Office.

SECTION 5. EFFECTIVITY. This Executive Order shall be effective immediately.
