Executive Order No. 2015-019

RECONSTITUTING THE BIDS AND AWARDS COMMITTEE AND NAGA CITY PROJECT MONITORING COMMITTEE:

Whereas, pursuant to Republic Act No. 9184, otherwise known as Government Procurement Reform Act, members of the Bids and Awards Committee of a Local Government Unit shall have a fixed term of one (1) year, renewable at the discretion of the head of the procuring entity;

Whereas, Executive Order No. 376, series of 1989, as amended by Executive Order No. 93, dated June 1, 1993, a City Project Monitoring Committee must be constituted to monitor all foreign and nationally-funded projects, including development projects funded from the Internal Revenue Allotment (IRA) share of local government units or supported by funds released directly to the City Government and projects funded from locally-generated resources which are implemented within the territorial jurisdiction of Naga City;

Whereas, both Special Bodies must be reconstituted in view of personnel movements, election of new members and legal requirement to the Local Chief Executive to restructure existing special bodies from time-to-time;

Now therefore, I, **JOHN G. BONGAT**, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

Section 1. The Bids and Awards Committee, its Technical Working Group and Secretariat are hereby reconstituted to be composed of the following:


