EXECUTIVE ORDER NO. 2015- 020

ORGANIZING THE TECHNICAL WORKING GROUP FOR THE SUSTAINABLE LIVELIHOOD PROGRAM 2.0 AND PROVIDING ITS COMPOSITION AND FUNCTIONS:

WHEREAS, the Sustainable Livelihood Program 2.0 spearheaded by the Department of Social Welfare and Development (DSWD) is being implemented in the City of Naga;

WHEREAS, the City Government of Naga is a partner of DSWD in the implementation of livelihood projects under the above mentioned program in selected barangays of the city; and

WHEREAS, a Technical Working Group is needed to be organized to participate and assist in the identification and assessment of livelihood projects that are viable and sustainable , as well as other activities to improve or increase the income of the target beneficiaries;

NOW, THEREFORE, I, JOHN G. BONGAT, City Mayor of Naga, by virtue of the powers and authority vested in me by law, do hereby order the following:

Section 1. Organization . The Technical Working Group (TWG) for the Sustainable Livelihood Program SLP 2.0 of the DSWD is hereby organized.

Section 2. Composition. The TWG shall be composed of the following:

- a. City Social Welfare and Development Officer
- b. City Planning and Development Officer
- c. City Agriculturist
- d. Metro PESO Manager
- e. Chairman, SP Committee on Social Welfare Services
- f. Chairman, SP committee on Livelihood and Manpower Development
- g. President, Liga Ng Mga Barangay
- h. Head, Solid Waste Management Office (SWMO)
- i. Representative from the Naga City People's Council (NCPC)
- j. President, Naga City Council for the Welfare of Women

The TWG shall elect from among themselves, the Chairman and Vice Chairman.

Section 3. Functions. The Technical Working Group (TWG) shall have the following functions:

a. Oversee the over- all implementation of Sustainable Livelihood Program 2.0 in the city and shall be responsible for fulfilling the city's commitments stipulated in the Memorandum of Agreement (MOA) between the City Government and DSWD.

b. Ensure proper coordination among the various local government departments and offices with similar programs/projects for the target beneficiaries to avoid duplications and optimize available resources to benefit the poorest of the poor, and

c. Participate in city project development and assessment workshops and ensure viability of the proposed projects prior to the endorsement for city assessment.


Section 4. Effectivity - this Executive Order shall take effect immediately.
