Executive Order No. 2015-028

CREATING A STEERING COMMITTEE FOR THE PROPER OBSERVANCE OF THE FAMILY WEEK IN THE CITY OF NAGA:

WHEREAS, the City Government of Naga recognizes the importance of strengthening and promoting unity, solidarity and stability of the "family" as the basic unit of society, as well as its socio-economic contributions to national development;

WHEREAS, Proclamation No. 60 dated 28 September 1992 declared the fourth (4th) week of September as "Family Week";

WHEREAS, there is a need to create a group that shall plan and implement programs and activities to ensure wider and more active participation of people from private and public sectors for the proper observance of the Family Week in the City of Naga;

NOW THEREFORE, I, JOHN G. BONGAT, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order:

Section 1. Creation. In order to address the aforementioned points, the Naga City Family Week Steering Committee is hereby created.

Section 2. Composition. – The Steering Committee shall be comprised of the following:

Section 3. Functions and Responsibilities. The Steering Committee shall have the following functions and responsibilities.

- a. Formulate, plan and implement appropriate programs and activities to ensure the successful observance of the family week;
- b. Ensure the active participation of all concerned during the week-long activity;
- c. Promote appreciation and awareness of current issues/charges in family situation and their consequences on family members; and
- d. Perform such other functions in accordance with this Executive Order.

Section 4. Effectivity. This Executive Order shall take effect immediately.
