RESOLUTION URGING THE NAGA CITY POLICE OFFICE (NCPO), THROUGH P/SUPT EL CID TALAY ROLDAN, DEPUTY CITY DIRECTOR FOR ADMINISTRATION, TO ENSURE POLICE VISIBILITY IN VARIOUS STRATEGIC AREAS TO EFFECTIVELY AND EFFICIENTLY MAINTAIN PEACE AND ORDER IN THE CITY OF NAGA:-

WHEREAS, upon invitation of the Sangguniang Panlungsod, P/Supt El Cid Talay Roldan, Deputy City Director for Administration of the Naga City Police Office appeared in open session to present the peace and order situation in the city given the reports on hold-up and riding in tandem cases;

WHEREAS, in his report, there are now 355 Personnel of the Naga City Police Office assigned in various areas of the city but observations persist concerning the continuing lack of visibility of police personnel;

WHEREAS, the student-participants to the Sangguniang Panlungsod-Student Participation Program (SP-SPP) suggested that the Naga City Police Office should strengthen police visibility, enhance coordination with school administrators to improve security measures to protect the students, and to install more CCTV Cameras to deter commission of and solve criminal incidents;

WHEREAS, the Sangguniang Panlungsod believes that one of the effective and efficient measures to maintain peace and order is through police visibility in various strategic areas of the city;

NOW, THEREFORE, on motion of Hon. Mila S.D. Raquid-Arroyo, seconded by Hon. David Casper Nathan A. Sergio;

BE IT RESOLVED, as it is hereby resolved, to urge the Naga City Police Office (NCPO), through P/Supt El Cid Talay Roldan, Deputy City Director for Administration, to ensure police visibility in various strategic areas to effectively and efficiently maintain peace and order in the City of Naga.
