RESOLUTION AUTHORIZING HIS HONOR, THE CITY MAYOR TO NEGOTIATE WITH THE LANDOWNERS/TENANTS WHOSE LAND WILL BE TRAVERSED BY THE PROPOSED CIRCUMFERENTIAL ROAD CONNECTING BARANGAYS CALAUAG AND SAN FELIPE, THIS CITY, AND TO RESOLVE ALL ISSUES PRIOR TO THE START OF THE PROJECT:-

**WHEREAS**, received by the Sangguniang Panlungsod for appropriate action is the letter dated September 4, 2014 of Engr. Leon B. Palmiano IV, city Engineer and Chairman of the Technical Working Group, requesting for comments/suggestions with respect to the documents submitted in connection with the proposed Calauag-San Felipe Circumferential Road;

**WHEREAS**, on July 22, 2014, the Sangguniang Panlungsod adopted Resolution No. 2014-265 prioritizing the Calauag-San Felipe Road Network Construction for Fiscal Year 2015, and directing the formation of a Technical Working Group for this project and requiring the TWG to submit its final report and recommendation within a month time upon its approval, and for other purposes;

**WHEREAS**, given its total length of 1.21 kilometers, it is imperative that negotiations be made with the landowners and tenants whose properties will be traversed by the proposed road network;

**WHEREAS**, finding the same to be in order and necessary to immediately implement the said project given its benefits to the residents in the area in particular and to the city in general;

**NOW, THEREFORE**, on motion of Hon. Jose A. Tuason, seconded by Hon. Mila S.D. Raquid-Arroyo, Hon. Elmer S. Baldemoro and Hon. Vidal P. Castillo;

**BE IT RESOLVED**, as it is hereby resolved, to authorize His Honor, the City Mayor to negotiate with the landowners/tenants whose land will be traversed by the proposed circumferential road connecting Barangays Calauag and San Felipe, this city, and to resolve all issues prior to the start of the project.
