ROSALES A.K.A. "CHINGLO", LEADER OF CHINGLO'S DRUG GROUP, WHO RANKED NUMBER 1 IN THE TOP 10 MOST WANTED PERSONS IN THE ENTIRE REGION V ON DRUG PERSONALITIES, LAST APRIL 29, 2015:-

WHEREAS, in his privilege speech during the 89th Regular Session of the Sangguniang Panlungsod, the Honorable Vidal P. Castillo reported and informed the body that the PNP-Naga Intelligence Group led by PCI Benito E Dipad Jr under the direct supervision of PSSUPT Narciso D Domingo, OIC-NCPO, for its successful arrest of Victor Lorenzo T. Rosales a.k.a. "CHINGLO", leader of CHINGLO's Drug Group which was reported to be operating in Naga City and the neighboring municipalities of Camarines Sur, last April 29, 2015;

WHEREAS, the operation was carried out by virtue of warrants issued by Hon. Maria Eden Huenda Altea, Presiding Judge, Branch 61, Regional Trial Court, Naga City, in relation to Criminal Case No. 2006-0480, for violation of Section 11 of Republic Act 9165 with no bail recommended and criminal Case No. 2006-0481, for violation of Section 12 of the same with recommended bail of Forty Thousand Pesos (P40,000.00);

WHEREAS, Rosales was ranked No. 1 among the Most Wanted Persons in Bicol of the Philippine Drug Enforcement Agency (PDEA) for illegal drug distribution, was ranked No. 6 among the 20 Most Wanted Persons in Bicol of the Philippine National Police, and was ranked No. 3 among the Most Wanted Persons of the Naga City Police Office;

WHEREAS, the arrest of Rosales, a known drug lord in the city since 2000, is expected to reduce illegal drug distribution in Camarines Sur;

WHEREAS, the PNP-Naga Intelligence Group's successful arrest of Rosales fully preserves the City Government's resolved to curb drug abuse and other criminalities in the City for the safety of its inhabitants;
