

BAC Resolution Declaring LCRB and Recommending Approval

WHEREAS, the City Government of Naga advertised the Invitation to Apply for Eligibility and to Bid for the Road Repair at Balatas Dumpsite, Bgy. Balatas, Naga City, in the City Government of Naga's website (www.naga.gov.ph), the G-EPS, service provider and at conspicuous place at the premises of the City Hall continuously for 7 days;

WHEREAS, in response to the said advertisements, eight (8) contractors submitted letters of intent and applications for eligibility, all were found eligible, and all purchased bid documents;

WHEREAS, seven (7) bids were submitted on September 1, 2015, and seven (7) bidders passed the preliminary examination of bids, as follows;
