

BAC Resolution Declaring LCRB and Recommending Approval

WHEREAS, the City Government of Naga advertised the Invitation to Apply for Eligibility and to Bid for the **Concrete Topping at Acacia & Tanguile Sts., Villa Grande Subd., Bgy. WHEREAS, the detailed evaluation of bids conducted on September 8, 2015 resulted in the following:







