

## BAC Resolution Declaring LCRB and Recommending Approval

WHEREAS, the City Government of Naga advertised the Invitation to Apply for Eligibility and to Bid for the CHB Box-type Drainage at Jacob & Bagumbayan Sts., Bgy. Bagumbayan Sur, Naga City, in the City Government of Naga's website (www.naga.gov.ph), the G-EPS, service provider and at conspicuous place at the premises of the City Hall continuously for 7 days;

WHEREAS, in response to the said advertisements, five (5) contractors submitted letters of intent and applications for eligibility, all were found eligible, and all purchased bid documents;

WHEREAS, four (4) bids were submitted on September 1, 2015, and three (3) bidders passed the preliminary examination of bids, as follows;
