

## BAC Resolution Declaring LCRB and Recommending Approval

**WHEREAS**, the City Government of Naga advertised the Invitation to Apply for Eligibility and to Bid for the Repair/Renovation of CEPPIO at City Hall Compound, J. Miranda Avenue, Bgy. **WHEREAS**, the detailed evaluation of bids conducted on September 28, 2015 resulted in the following:






