

Resolution Declaring LCRB and Recommending Approval

WHEREAS, the City Government of Naga advertised and posted the Invitation to Apply for Eligibility and to Bid of the **Supply and Delivery of Medicines** in the City Government of Naga website (www.naga.gov.ph), the G-EPIS and at conspicuous place at the premises of the City Government of Naga continuously for 7 days;

WHEREAS, in response to the said advertisement, SIX (6) bidders submitted letters of intent and applications for eligibility and purchased eligibility and bid documents;

WHEREAS, SIX (6) bids were submitted on August 5, 2015 and all passed the preliminary examination of bids;


