

BAC Resolution Declaring LCRB and Recommending Approval

WHEREAS, the City Government of Naga advertised the Invitation to Apply for Eligibility and to Bid for the Road Concreting at Employees Housing, Bgy. Del Rosario, Naga City, in the City Government of Naga's website (www.naga.gov.ph), the G-EPS, service provider and at conspicuous place at the premises of the City Hall continuously for 7 days:




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:
