

BAC Resolution Declaring LCRB and Recommending Approval

WHEREAS, the City Government of Naga advertised the Invitation to Apply for Eligibility and to Bid for the **Extension of Single Phase Line & Installation of 25 KVA at NC Employees Project Phase I, Del Rosario, Naga City**, in the City Government of Naga's website (www.naga.gov.ph), the G-EPS, service provider and at conspicuous place at the premises of the City Hall continuously for 7 days;

WHEREAS, in response to the said advertisements, **four (4)** contractors submitted letters of intent and applications for eligibility, all were found eligible, and all purchased bid documents;
