Executive Order No. 2017-007

ESTABLISHING THE SAGOP CREEK REVITALIZATION PROJECT TECHNICAL WORKING GROUP (TWG), DEFINING ITS COMPOSITION AND FUNCTIONS, AND PROVIDING TIMETABLE FOR OUTPUT SUBMISSION:-

WHEREAS, Naga City has embarked on an extensive revitalization and rehabilitation of the waterways in its territory, including the Naga River;

WHEREAS, the city is fully committed to the pursuit of environmental conservation, climate change adaptation, and disaster resilience, which translates into existing programs, projects, and activities;

WHEREAS, the Sagop Creek is one of the vital natural waterways within the city that needs rehabilitation and revitalization;

WHEREAS, there is a possible funding support from the Climate Change Commission for projects similar to the creek revitalization which will not only promote clean environment and a culture of cleanliness, but also public safety and welfare;

NOW THEREFORE, I, JOHN G. BONGAT, Mayor of the City of Naga, by virtue of the powers vested in me by law, do hereby order the following:

Section 1. Creation and Composition. The Technical Working Group (TWG) for the Sagop Creek Revitalization Program is hereby created with the following composition:

Section 2. Functions. The TWG is hereby tasked to perform the following functions:

1. Prepare the baseline data and survey for Sagop Creek including the following: map of the creek vicinity (per barangay), houses along the creek, actual photos/videos;

2. Draft the project proposal for funding by the Climate Change Commission, to be submitted to the City Mayor on or before 15 March 2017;

Section 3. Funding. Resources for the operation of the TWG shall be charged against existing appropriations for environment and climate change/disaster risk reduction management (DRRM) and of concerned departments.

Section 4. Effectivity. This Executive Order shall take effect immediately.
