RESOLUTION AUTHORIZING HIS HONOR, THE CITY MAYOR TO ENTER INTO A DEED OF EXCHANGE WITH MR. CRISANTO R. AMASA AND MR. PEDRO A. ESPERIDA WITH RESPECT TO TWO PARCEL OF LANDS WHICH WILL BE UTILIZED AS PORTION OF THE PROPOSED ROAD EXTENSION PROJECT THAT WILL CONNECT THE UNFINISHED CONCRETE ROAD BESIDE MORADA RAMOS ELEMENTARY SCHOOL THAT WILL ULTIMATELY BE CONNECTED TO CARARAYAN-SAN ISIDRO ROAD, SUBJECT TO THE RATIFICATION BY THE SANGGUNIAN PANLUNGSOD:-

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the letter dated November 9, 2016 of His Honor, the City Mayor, requesting for an authority to enter into a Deed of Exchange with Mr. Crisanto R. Amasa and Pedro A. Esperida with respect to two parcel of lands which will be utilized as portion of the proposed road extension project;

WHEREAS, the said parcels of land are specifically described as Lot 1-M-3-A (Portion of Lot 1-M-3, Psd-05-0418804) with an area of 274 square meters, and Lot 1-M-3-B (Lot 1-M-3, Psd-05-0418804 Portion) with an area of 320 square meters, both located in Barangay Carolina, Naga City;

WHEREAS, finding the said request for authority to be in order and necessary to connect the unfinished concrete road beside Morada Ramos Elementary School that will ultimately be connected to Cararayan-San Isidro Road;
