WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the letter dated February 22, 2017 of Mr. Mr. Albert Avecilla, General Manager, EV Wealth Inc., expressing their intent to apply for 60 units E-Trike Franchise;

WHEREAS, finding the conduct of a test run to be in order and necessary to determine the viability of the E-Trike units of EV Wealth Inc.;

NOW, THEREFORE, on motion of Hon. Joselito S.A. del Rosario, seconded by Hon. Elmer S. Baldemoro and Hon. Julian C. Lavadia Jr;

BE IT RESOLVED, as it is hereby resolved, to Mr. Albert Avecilla, General Manager, EV Wealth Inc., to conduct a test run for E-Trikes, subject to the following terms and conditions:

1. The test run shall be for the period of ninety (90) days;
2. Only five (5) units of E-Trike shall be allowed in the test run;
3. The units shall not be allowed to ply national roads;
4. The Traffic Management Center of the Public Safety Office and the Naga City PNP shall look into the allowable number of passengers, the safety of the driver and passengers, and shall regularly update the Sangguniang Panlungsod on the status of the test run, and to render a terminal report after the 90-day period.

LET COPIES of this resolution be furnished His Honor, the City Mayor for his concurrence, Mr. Albert Avecilla, General Manager, EV Wealth Inc., the Naga City Police Office and the Public Safety Office for their information and guidance.
