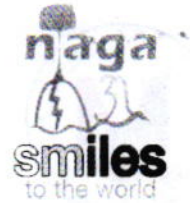

**RESOLUTION APPROVING THE ANNUAL BUDGET OF BARANGAY SAN FELIPE, CITY OF NAGA FOR CALENDAR YEAR FROM JANUARY 1 TO DECEMBER 31, 2017 AS EMBODIED UNDER APPROPRIATION ORDINANCE NO. 2017-001, SERIES OF 2017 INVOLVING THE AMOUNT OF ELEVEN MILLION NINE HUNDRED EIGHTY FOUR THOUSAND SIX HUNDRED FORTY-SEVEN PESOS (P11,984,647.00) IN CONFORMITY WITH EXISTING BUDGETARY RULES AND REGULATIONS AND IN ACCORDANCE WITH THE PROVISIONS OF THE LOCAL GOVERNMENT CODE OF 1991:-**
