RESOLUTION AUTHORIZING HIS HONOR, THE CITY MAYOR, TO NEGOTIATE WITH THE LAND OWNERS TO BE AFFECTED BY THE ROAD NETWORK CONSTRUCTION AT BARANGAYS CARARAYAN AND SAN ISIDRO EN ROUTE TO THE PROPOSED SANITARY LANDFILL IN BARANGAY SAN ISIDRO, NAGA CITY:-

WHEREAS, received by the 12th Sangguniang Panlungsod is the letter dated 6 March 2017 of City Environment and Natural Resources Officer Oscar P. Orozco submitting the list of lot owners to be affected by the proposed road network construction at Barangay Cararayan and San Isidro en route to the proposed San Isidro Sanitary Landfill;

WHEREAS, also received by the 12th Sangguniang Panlungsod is Resolution No. 2017-02 of the Naga City Appraisal Committee determining the fair market value of the lands to be affected by the aforesaid road network construction;

WHEREAS, the properties identified are necessary in building an access road going to the San Isidro Sanitary Landfill, a vital solid waste management infrastructure of the city government;

WHEREAS, negotiation with the owners of the affected lots, starting at a price of One Hundred Fifty Pesos (P150.00) per square meter, is in order and beneficial to the development of the City of Naga;


