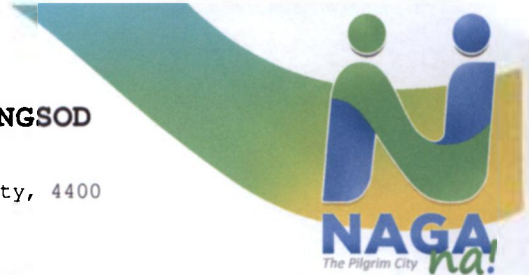

AN ORDINANCE REVERTING TO UNAPPROPRIATED BALANCE THE AMOUNT OF THIRTEEN MILLION TWO HUNDRED SEVENTY THOUSAND PESOS (P13,270,000.00) FROM SAVINGS FROM THE EXISTING APPROPRIATIONS FOR PERSONAL SERVICES, AND APPROPRIATING THE SAME TO COVER THE GRANT OF SERVICE RECOGNITION INCENTIVE TO ALL PERMANENT AND CASUAL EMPLOYEES OF THE NAGA CITY GOVERNMENT AT TEN THOUSAND PESOS (P10,000.00) EACH PURSUANT TO ADMINISTRATIVE ORDER NO. 45:-

On joint and collective motion

Be it ordained by the Sangguniang Panlungsod of Naga, that:

SECTION 1. - The amount of Thirteen Million Two Hundred Seventy Thousand Pesos (P13,270,000.00) from savings from the existing appropriations for Personal Services is hereby reverted to unappropriated balance, and appropriated the same to cover the grant of Service Recognition Incentive to all permanent and casual employees of the Naga City Government at Ten Thousand Pesos (P10,000.00) each pursuant to Administrative Order No. 45;

SECTION 2. - This ordinance shall take effect upon its approval.




